

## **AMRPA PAC Solicitation Prior Authorization**

AMRPA PAC's primary goal is to support and enhance the effectiveness of the medical rehabilitation field's political advocacy efforts and strengthen our grassroots capabilities. By collecting voluntary contributions, AMRPA members are able to pool their resources to help elect qualified Members of Congress whose views and voting records support the issues affecting the medical rehabilitation field.

AMRPA member organization executive and administrative personnel who are paid on a salary basis and who have policymaking, managerial, professional, or supervisory responsibilities may be solicited to make a voluntary contribution to AMRPA PAC if and only if their organization has given prior authorization for this solicitation.

AMRPA PAC promotes responsibility in government and encourages participation of AMRPA member organizations and their employees in the political and elective process. AMRPA PAC must make a written request to AMRPA members for permission to solicit your organizations. Prior approval (authorization) is necessary before AMRPA PAC may solicit your organization and your employees. Before AMRPA PAC may solicit contributions from you, your organization's primary AMRPA contact must first submit this solicitation authorization form. Completing this authorization is optional, and organizations that choose not to enroll will not be disadvantaged.

Please complete the form below to enroll your organization for the years listed. The Federal Election Commission (FEC) requires a separate signature for each year of authorization. You may withdraw this authorization at any time. The AMRPA PAC is a separate segregated fund established by AMRPA to collect funds to be used for political purposes. Contributions are voluntary and you have a right to refuse to contribute without reprisal. The amount given by the contributor, or the refusal to give, will not benefit or disadvantage the person being solicited. Contributions to the AMRPA PAC cannot be deducted as a charitable contribution for federal tax purposes. Federal law requires the AMRPA PAC to use its best effort to collect and report the name, mailing address, occupation, and the name of the employer of the individuals whose contributions exceed \$200 per calendar year. Contributions from foreign nationals and corporations are prohibited.
